Procedure:

- A. Identification of Accounts Responsibility: Patient Account Representative
 - 1. The Patient Account Representative will review all bankruptcy notices immediately upon receipt.
- B. Filing Creditors Claims
 - 1. If the account has been transferred to a collection agency, the Patient Accounts Representative will call the Collection Agency to advise them of the bankruptcy filing. Send a copy of the claim to the agency if they have not received a copy.
 - 2. Document activity in the computer system on the patient's account.
 - 3. Select all encounters that fall prior to the date of Bankruptcy, and enter effective date of bankruptcy.
 - 4. If it is Chapter 13, send in a proof of claim, which includes itemized billing.
 - 5. Chapter 7 is liquidation of patients accounts, still apply adjustment.

ASSESSMENT OF NEED

Department : Mid-Valley Clinic

Assessment of Need: Okanogan Valley Clinic was purchased by Mid-Valley Hospital in 2003, and the carpeting in place then was not replaced. It is likely the carpeting is at least 20 years old. The exception is the carpeting in the 2005 ortho addition. However, that carpet is bunched up in many places and poses a tripping hazard as well as looking stained and warn. The flooring in exam rooms has also been in place for a minimum of 15 years in most all areas of the clinic. With the advent of COVID, the carpeted areas especially cannot adequately be sanitized. Linoleum is worn, discolored, and cracked in places. Tile in the ortho waiting room also poses a tripping hazard from the carpeted area to the front desk area. Researching, we found MONDO flooring, which is a rubber flooring that is durable, provides comfort with its thickness, is sustainable, easy to maintain, and is anti-bacterial and anti-microbial. It is the same flooring that the Omak School District has used and they recommend it as durable, easy to maintain, and lasting, amongst other benefits. Similar flooring that meet these specifications would be considered. This project would include the removal of existing flooring, assessment of subflooring and possible replacement if needed, installation of the rubber flooring, Installation of a 4.5" rubber base floor molding, and disposal of old flooring.

PHASE I & II: Replace all carpeted areas with the exception of carpeted offices. Estimated square footage is approximately 4,792 square feet.

PHASE III & IV: Replace flooring in exam rooms, office rooms, x-ray rooms, bathrooms, and remaining floors. Total square footage is approximately 7,847 square feet.

Financial Impact: Total cost for replacing all flooring is estimated to be between \$240,000 and \$300,000. We have a Federal RHC COVID grant that must be used by June 30, 2021, and a DOH Ship Grant for \$83,000 that must be used by September 2021. Remaining funding needed to complete the entire project would total \$107,000 to \$167,000 depending upon approved bid.

Staff Resources: To minimize down time and impact on patient care services in the clinic, the preference is for successful bidders to complete a section of work over the weekend. This can be flexible with the shifting of patient care services within the clinic to accommodate additional week days. Maintenance would need to clear areas that are to have flooring installed prior to their coming on site. IT would need to move electronic equipment and phones in areas floors are being replaced. Staff would have to move their work stations during construction in their areas.

Impact on Physicians: Days scheduled to see patients in clinic may need to be changed or cancelled or providers moved to another area to see their scheduled patients.

<u>Staff Education</u>: Staff will be educated on how to care for the new flooring and on any safety concerns while the construction team is on site if here during clinic hours.

Collaboration with other Community Efforts: N/A

<u>Promotion of Project</u>: Improving the overall appearance of the clinic will provide curb appeal as well as a clean appearance to potential patients.

Use of Volunteers: N/A

Patient Safety: The proposed flooring provides a comfortable, non-slick surface and is designed with safety in mind. It will also provide an easily sanitized, anti-bacterial and anti-microbial surface. Replacing the carpeted areas in orthopedics clinic area will resolve a long-standing tripping hazard due to the carpet bunching up in places.

Employee Safety: Same as above for patient safety.

<u>Quality Improvement</u>: Having one flooring throughout the building will create efficiency in maintenance as well as superior sanitation of floor surfaces.

Department : Mid Valley Therapy

<u>Assessment of Need</u>: We are requesting the LSI 4 Channel Telemetry System Patient Monitoring and Clinical Documentation System for Cardiac Rehabilitation. This includes 4 channel Telemetry system, central monitoring station with software, ECG transmitters, 4 telemetry modules, touch to chart module with touch screen, standard installation and in service training program, 2 SPO2 monitors and modules, software license, and required interface to be compatible with Cerner.

Cardiac Rehabilitation is a medically supervised, multi-faceted, team based secondary prevention program aimed to improve heart health for individuals whom have suffered from a cardiac related event or condition and/or a cardiac procedure. It includes supervised and cardiac monitored exercise training, patient education and heart healthy skill development. It typically consists of 18-36 one hour sessions in an outpatient setting that is customized to meet each patient's individual needs.

Financial Impact: The revenue for Cardiac Rehabilitation services are:

93798 \$124 31-89min of Exercise with continuous EKG

93797 \$119 31-89 min of Exercise without continuous EKG

You can charge 2 units if patient performs 90 min of exercise for either code.

Staff Resources: Our cardiac rehabilitation program will rely on various departments including: therapy, nursing, respiratory, and possibly dietary.

<u>Impact on Physicians</u> : Their patients will be able to participate in Cardiac rehabilitation locally, versus having to commute 1-2 hours.

<u>Staff Education</u>: Training for the LSI system will be provided by LSI in a 4 days staged onsite in-service training program.

<u>Collaboration with other Community Efforts</u>: Central Washington Hospital has been an extremely helpful mentor for all stages of Cardiac Rehabilitation planning process. They will be referring all cardiac rehab patients in our area to our program. Offer was made to have Cardiologist from Wenatchee involved in our program.

<u>**Promotion of Project</u>**: Director of Marketing will be involved to promote community awareness and education of our Cardiac Rehabilitation program. Information will be presented to our local and neighboring providers as well.</u>





Prior to each session, patient's vitals will be taken and documented. Continuous EKG during exercise regime will be completed and if any medical concerns arise, actions will be taken. There will be a daily physical available as well as a Medical director with expertise in Cardiology will be following each patient. All staff will have adequate training in CPR, ALCS, code procedures, and EKG assessment.

<u>Employee Safety</u>: Each patient will be assessed prior to starting the program to ensure they are IND with transfers and safe with using available equipment. Cardiac rehabilitation is NOT physical therapy. If patient is not appropriate for rehab due to their and staff safety, it may be determined that physical therapy would be an appropriate treatment first.

<u>Ouality Improvement</u>: Cardiac rehabilitation has several benefits including: controlling heart disease symptoms, stopping or reversing damage to blood vessels in the heart, lessens the physical and emotional effects of heart disease, improves stamina and strength, improves confidence and well-being and ultimately reduces mortality rates. Providing cardiac rehabilitation to our community members that have suffered from a cardiac event or procedure is excellent customer service. This will greatly enhance the overall care of our patients, especially those suffering from cardiac related events and procedures.
